It appeared to this house, not only that it was the wish of a majority of Caroline county that fuch a bill should pass, but that Choptank Bridge was far more convenient, in every respect, for the seat of justice, than the place where it is fixed at present, or the place prayed for by the counter

The inclination of the people may be fairly inferred from the event of the last election of delegates, compared with the circumstances under which it took place; and the superiority of Choptank Bridge over Pig-Point, the place prayed for as aforesaid, seemed sufficiently evident, on account of the pub-·lic roads concentring in the former fituation, its better accommodations, and its exemption from a

variety of disadvantages to which the latter is subject.
