

- No. 4. An act for the relief of William Robertson, of Montgomery, and Robert Amos, junior, of Harford county.
- No. 5. An act for the preservation of the breed of wild deer, and for other purposes therein mentioned.
- No. 6. An act to ratify certain articles in addition to, and amendment of, the constitution of the United States of America, proposed by congress to the legislatures of the several states.
- No. 7. An act to straighten, amend and repair, the public road in Frederick county leading towards Carlisle, in Pennsylvania.
- No. 8. An act to regulate the assize of bread.
- No. 9. An act for the relief of Sarah Hall, of Baltimore county.
- No. 10. An act for the benefit of Samuel Chase, of Baltimore-town.
