**T**HE senate met. Present as on Saturday. The proceedings of Saturday were read.

The resolution respecting the advance of money for erecting buildings for the accommodation of the general government, was sent to the house of delegates by Daniel Carroll, Esquire.

The bill, entitled, An act to enable Richard Tilghman Earle to sell and convey certain property of his deceased father Richard Tilghman Earle, was read the first time and ordered to lie on the table.

The bill, entitled, An act to enable the inhabitants of Saint John's parish, in Queen-Anne's and Caroline counties, to elect vestrymen and churchwardens for said parish, was read the first time and ordered to lie on the table.

Mr. Burges, from the house of delegates, delivers to the president the following resolution:

BY THE HOUSE OF DELEGATES, NOVEMBER 22, 1790.

RESOLVED, That the treasurer of the western shore be directed to credit the late house of John M<sup>r</sup>Henry, and company's note, for the sum of one hundred and eighty-three pounds five shillings and ten-pence specie, in certificates at four for one.

BY THE HOUSE OF DELEGATES, NOVEMBER 22, 1790.

MAY IT PLEASE YOUR HONOURS,

THIS house propose, at 12 o'clock to-morrow, to go into a ballot for the appointment of a register of wills for the county of Allegany, and have appointed Mr. Stone and Mr. Gough to join a committee from your house to examine the ballot boxes. Mr. Gabriel Jacobs and Mr. William M<sup>r</sup>Mahon are nominated by this house.

The bill, entitled, An act to establish a bank in Baltimore-town, was read the second time, and passed with the following amendments:

Amendments proposed. After the word "banks" in the 3d line of the first page, strike out the remainder of the preamble. In the 9th line from the bottom of the 2d page, strike out the words "his share or shares at his pleasure," and instead thereof insert "his stock in the said bank, or any part thereof, at his pleasure, not being less than one complete share or shares." At the end of the 2d section in the 4th page add the following section: "And be it enacted, that in the appointment of a cashier of the said bank, a majority of the votes of nine directors shall be necessary to a choice."

The president communicates to the senate the memorial of the visitors and governors of Saint John's college; which was read, referred to the consideration of the house of delegates, and, with the bill to establish a bank in Baltimore-town, sent by Richard Ridgely, Esquire.

The following message was prepared, agreed to, and sent to the house of delegates by Samuel Hughes, Esquire:
