## R I D A Y, November 26, 1790.

HE senate met. Present as on yesterday. The proceedings of yesterday were read. The bill to alter and change the name of Charles Ridgely Carnan, and others, according to the will of captain Charles Ridgely, of Baltimore county, deceased, was read the second time by especial order, and the question was put, That the said bill do pass? RESOLVED, That the purchasers of Ebenezer Mackie's confiscated property be released therefrom, and that the faid property be restored to the faid Ebenezer Mackie in the same manner as if it never had been conficated; and that the treasurer of the western shore be and he is hereby directed to deliver to the faid Mackie his bond now in the office for one third of faid property, purchased by him at a refale, on condition that the faid Mackie pay to the treasurer aforefaid the amount of all expences which this state may have incurred by reason of the consiscation, sale and resale, of the said property, and all expences incurred by the state in any suit or suits at law, or in equity, on account of the faid property.

No gentleman is named by this house in addition to those nominated by your house.

H. RIDGELY, jun. clk. By order, The senate being ready to proceed to the election of a senator to represent this state in the senate of the United States, Charles Carroll, of Carrollton, Esquire, being in the nomination, begged leave to withdraw, and upon leave being given, withdrew accordingly.
