Strike out the 16th and 17th lines, and instead thereof insert "the said associate justices, or any two of them, shall have all the jurisdiction and powers expressed in the first recited act." In the 7th line from the bottom of the 1st page, strike out the words "two hundred," and insert the word "fifty." At the end of the bill insert the following proviso: "Provided nevertheless, That one of the justices of the said court shall have the same power and jurisdiction, under this act, as are vested in one of the justices of the said court in virtue of the act first herein before recited."
