The supplement to an act, entitled, An act to provide for the surther encouragement and establishment of Washington college, and to an act, entitled, An act for founding a college on the westernshore of this state, and constituting the same, together with Washington college on the eastern shore, into one university, by the name of the University of Maryland, passed November session, seventeen, hundred and eighty-four, was read the second time, passed, and sent to the house of delegates by the clerk of the senate.
