Amendment proposed. After the word "dues" in the seventh line from the top, insert as follows: "to be applied, in the first place, to the payment of a debt due from the said Christie to the state of Maryland, and so much of the remainder as may be necessary, to be applied towards payment of the debts due from the said Christie to the counties of Baltimore and Harford, and any person or persons whatever, at the time of his attainder."

On motion, William Tilghman, Esquire, brings in a bill, entitled, An act to repeal part of an act, entitled, A Further supplement to the act for establishing a company for opening and extending the navigation of the river Patowmack; which was read the first and second time by especial order,
