THE senate met. Present the same members as on yesterday. The proceedings of yesterday were read.

The bill, entitled; An act for the inspection of salted provisions exported and imported from and to George-town, in Montgomery county, was sent to the house of delegates by the clerk of the senate.

The resolution respecting surplus interest, was read the second time by especial order, and the question was put, That the senate assent thereto? And the yeas and nays being called for, appeared as follow:

The bill for the prevention of lotteries, the bill to prevent lotteries in Cæcil county, and the bill for the collection of the county charges in Allegany county, were sent to the house of delegates by the clerk of the senate.

The bill for the benefit of Daniel Hiefter, junior, of Pennsylvania, was read the second time and will not pass, and sent to the house of delegates by the clerk of the senate.

William Perry, Esquire, from the committee appointed to report amendments to the bill, entitled, An act to lay out and open roads from Denton, the seat of justice in Caroline county, to different parts of said county, and the same, when opened and laid out, to be the public roads of said county, brings in and delivers to the president sundry amendments; which were read and ordered to lie on the table.

The bill, entitled, A Further supplement to the act respecting the settlers on the reserved lands to the westward of Fort Cumberland, was read the second time and will not pass; which was sent to the house of delegates by the clerk of the senate.

The bill to increase the allowance to jurymen of the general court and the several county courts in this state, was read the second time, and the question was put, That the said bill do pass? And the yeas and nays being called for, appeared as follow:
