Amendments proposed. In the last line of the first page, after the word "shall" insert "each." In the last line of the first page, strike out the word "an" and insert "a clear real." Strike out the fifth and fixth sections. At the end of the bill add the following clause: "And be it enacted, That this act shall continue and be in force for the term of three years, and to the end of the next session of affembly which shall happen thereafter.'
