

VOTES AND PROCEEDINGS, November, 1794. 51

The clerk of the house of delegates delivers the engrossed bill No. 61, with the paper bill thereof; which engrossed bill was thus endorsed; "By the house of delegates, December 26, 1794: Read and assented to:

The resolution approving the conduct of the executive in relation to the stock of this state in the bank of England, was read the second time and dissented to, and sent to the house of delegates by the clerk.

The resolutions respecting the agent, were read the second time by especial order and assented to with the following amendment to the last.

Amendment proposed. In the last resolution strike out from the word "and" in the fourth line from the bottom to the end of the said resolution, and insert "the said agent is hereby directed to report thereon to the general assembly at their next session."

The act to continue the acts of assembly therein mentioned, was read the second time by especial order and will pass.

The resolution in favour of Allen B. Duckett, was read the second time by especial order and assented to.

On motion, the following message was prepared, read, and agreed to.

BY THE SENATE, DECEMBER 26, 1794.

GENTLEMEN,

WE have assented to your resolution of this date in favour of Allen B. Duckett, and persuade ourselves that you will authorise the treasurer to pay Mr. Henry Warfield, our assistant clerk, whom we consider as equally meriting an additional compensation for his attention and services, the sum of fifteen pounds current money.

SATURDAY, December 27, 1794.

THE senate met. Present the same members as on yesterday. The proceedings of yesterday were read.

The bill, entitled, An act for the relief of sundry insolvent debtors, and the message respecting said bill, the resolution respecting the government house, and the resolution in favour of Allen B. Duckett, together with the message respecting said resolution, were all sent to the house of delegates by the clerk.

The paper bill No. 61, was sent to the house of delegates by the clerk.

The resolution empowering the governor and council to draw on the treasury for the incidental expences of government, was read the second time by especial order and assented to, and sent to the house of delegates by the clerk.

The resolution in favour of William Slade, was read the second time and assented to, and, with the following message, was sent to the house of delegates by the clerk.
