

The bill, entitled, A supplement to the act, entitled, An act directing the manner of suing out attachments in this province, and limiting the extent of them, the bill, entitled, An act respecting executions issued from one county to another, and to compel the attendance of witnesses summoned from one county to another, the bill, entitled, An act making a temporary alteration in the turnpike road directed to be laid out from Baltimore-town towards Frederick-town, and the resolution in favour of Benjamin Rogers, were sent to the house of delegates by the clerk.

M O N D A Y, November 23, 1795.

**T**HE senate met. Present the same members as on Saturday, except Robert Smith, Esquire, who had leave of absence. John Campbell, Esquire, appeared in the senate. The proceedings of Saturday were read.

The clerk of the house of delegates delivers to the clerk of the senate a bill, entitled, An act to build a market house in Bentz-town, an addition to Frederick-town, and for the regulation of said market, thus endorsed; "By the house of delegates, November 21, 1795: Read the first time and ordered to lie on the table.

And the following resolution:

BY THE HOUSE OF DELEGATES, NOVEMBER 18, 1795.

RESOLVED, That the treasurer of the western shore be and he is hereby directed, on the application of William Compton, of Charles county, to credit the said Compton on his bond, now in the possession of the said treasurer, with the amount of three years interest of his original bond, agreeable to payments made thereon by the said William Compton.

Which said bill and resolution were severally read the first time and ordered to lie on the table.

The president communicates to the senate a letter from John Callahan, register of the land-office of the western shore, enclosing an account of taxes received by him on the several proceedings in said office, ending on the second day of October last, and amounting to the sum of £. 34 10 current money; which was read and referred to the consideration of the house of delegates, and sent there by the clerk.

The bill, entitled, An act to authorise the holding of a lottery for erecting a steeple to the Lutheran church in Frederick-town, in Frederick county, was read the second time and will not pass.

The bill, entitled, An act to confirm an act passed at November session, one thousand seven hundred and ninety-four, entitled, An act to alter such parts of the constitution and form of government which prevent persons conscientiously scrupulous of taking an oath from being members of the legislature, electors of the senate, or to hold offices of profit and trust, was read the second time and will pass, and, with the last mentioned bill, was sent to the house of delegates by the clerk.

On motion, ORDERED, That the bill, entitled, An act to relinquish the right of the state to the land therein mentioned, be read the second time on to-morrow.

The bill, entitled, An act to survey, continue and extend, certain streets therein mentioned, lying in the additions to George-town, in Montgomery county, was read the second time and will pass with the proposed amendments.

Amendments proposed. Second page, 1st line, strike out the word "November," and insert "August." In the 8th line of the same page, strike out the word "November," and insert "August." After the word "seven," in the last line of the 3d page, insert "Provided, that nothing herein contained shall be deemed or taken to affect the right of any infant, feme-covert, or person non compos mentis, or beyond sea, from appealing from the said first valuation, and having a second valuation according to the provisions of this act, if he, she or they, shall prosecute the same within six months after such disability shall be removed."

The bill, entitled, A supplement to an act, entitled, An act for the relief of the poor of Calvert county, was read the second time and will pass.

The resolution in favour of Dennis Griffith, was read the second time and assented to.

The senate adjourns until to-morrow morning 10 o'clock.

James M'Henry, Esquire, from the committee, brings in and delivers to the president the bill, entitled, An act to lay out a turnpike road from the City of Washington to Baltimore-town; which was read the first time and ordered to lie on the table.

The
