

And the following declaration relative to the president of the United States :

The general assembly of Maryland, impressed with the liveliest sense of the important and disinterested services rendered to his country by the president of the United States, convinced that the prosperity of every free government is promoted by the existence of rational confidence between the people and their trustees, and is injured by misplaced suspicion and ill founded jealousy, considering that public virtue receives its best reward in the approving voice of a grateful people, and that when this reward is denied to it, the noblest incentive to great and honourable actions, to generous zeal and magnanimous perseverance, is destroyed, observing, with deep concern, a series of efforts, by indirect insinuation or open invective, to detach from the first magistrate of the union the well earned confidence of his fellow-citizens, think it their duty to declare, and they do hereby declare, their unabated reliance on the integrity, judgment and patriotism, of the president of the United States.

Unanimously assented to in the house of delegates.

Which said bill and declaration were severally read the first time and ordered to lie on the table.

The bill, entitled, An act to build a market-house in Bentz-town, an addition to Frederick-town, and for the regulation of said market, was read the second time and will pass.

The bill, entitled, An act to authorise and empower the levy court of Montgomery county to assess and levy annually a sum of money for the purposes therein mentioned, was read the second time by especial order and will not pass.

The bill, entitled, An act to empower John C. Beatty to collect the balances due him as sheriff and collector of Allegany county, was read the second time and will pass with the proposed amendments.

Amendments proposed. Strike out from the word "collector" in the 14th line of the first page to the end of the preamble, and insert "And this general assembly, for the reasons stated in said petition, are willing to grant him some indulgence." After the word "fees" in the 3d line of the 2d page, insert "for the year seventeen hundred and ninety-four." At the end of the bill add the following proviso: "Provided always, and be it enacted, That the said John C. Beatty, or some person or persons authorised by him, shall, at least ten days before execution or distress of property for the balances aforesaid, deliver to the person charged, or leave at his or her place of abode, a proved account, stating the taxes and the amount of fees, or such part thereof as may be claimed as due, together with all payments that may have been in any manner made by such person, and shall give at least five days notice, by advertisement at the most public places in the neighbourhood, of the time and place of sale, in case of such execution or distress; and provided also, that all the books of the said John C. Beatty, and his deputies, in which his accounts as sheriff and collector are stated and kept, shall be deposited in the hands of some person in the county town of the county aforesaid, to be inspected and examined by any person or persons who shall apply for the same, in order to ascertain any payments that may have been made upon his or their account."

The declaration relative to the president of the United States, was read the second time by especial order and unanimously assented to.

On motion, Charles Carroll, of Carrollton, Esquire, delivers to the president the following resolution, which was read the first and second time by especial order and assented to.

BY THE SENATE, NOVEMBER 25, 1795.

RESOLVED, That the declaration of the general assembly, passed this day by both branches of the legislature, relative to the president of the United States, be printed in the Annapolis, Easton, Frederick, Baltimore and George-town newspapers.
