JANUARY 5, 1798. OF DELEGATES, THE HOUSE BY

Whereas agreeably to an act of affembly, entitled, An act for calling out of circulation the quota of this state of the bills of credit islued by congress, and the bills of credit emitted by acts of assembly under the old government, and by the resolves of convention, made and passed at October session, seventeen hundred and eighty, considerable sums of money have been paid into the treasury for the purpose of discharging debts due to British merchants or creditors, which sums so paid in the treasurer was directed by the act aforesaid to retain in his office, liable to the attachment of creditors, and subject to the future direction of the general affembly: And whereas it has been determined that such payments into the treasury are not to be deemed payments to the creditors, but suits have been actually instituted, and recoveries had, against debtors, notwithstanding the payments into the treasury aforesaid: And whereas there are frequent applications for a return of the money fo paid in; therefore, RESOLVED, That the treasurer of the western shore be and is hereby directed and empowered, upon the application of the person or persons who lodged any sum or sums of money as aforesaid for the purpose aforesaid, or upon the application of his or their legal representatives, to return to him or them the sum or sums so deposited and now retained by virtue of the act aforesaid.

RESOLVED, That the treasurer, before he returns the money deposited, be satisfied, by competent proof, that the person applying has paid, or secured to be paid, to the British creditors, the debt for the

payment of which the money was lodged with the treasurer.
