RESOLVED, That William Kilty include in the edition of the laws which he is now compiling under the resolutions of the last general assembly, and agreeably thereto, the acts passed during the present session.

RESOLVED, That the printer to the state be and he is hereby directed to have the said laws, when finished, bound in a neat and substantial manner, and as expeditiously as possible, and delivered to the governor and council.

RESOLVED, That the laws for the chancery court, court of appeals, general courts, county courts, orphans courts, land-offices, the governor and council, the senate and the house of delegates, be marked on the side for their use respectively, and that those for the several states, for congress, and for the secretary of state, be handsomely bound in calf-skin, and marked for their use respectively.

RESOLVED, That the treasurer be and he is directed to advance to William Kilty the sum of two thousand dollars in part of the compensation to be allowed for the whole work.
