Whereupon it is declared in the senate, that Thomas Buchanan, Arthur Shaaff, James Thomas, John Davidson and Samuel Ridout, are duly elected a council to the governor.

By THE HOUSE OF DELEGATES, NOVEMBER 12, 1800.

GENTLEMEN OF THE SENATE,

THE office of register of wills being vacant in Harford county, we propose, with the concurrence of your house, to go into an election immediately. Mr. Abraham Jarrett and Mr. Alexander Lawson Smith are nominated by this house to fill this office, and we have appointed Mr. Nelson and Mr. Edmondson, in conjunction with any members of your house, to examine the ballots.
