Strike out from the word "acquired" in the second line of the second page to the end of the bill, and insert "provided always, that nothing in this act contained shall in any manner defeat or affect any right, title or claim to the said property, or any part thereof, acquired or prosecuted by any person or persons whatever before the passage of this act; and provided also, that unless the said Frederick Saler shall, on or before the first day of June next, proceed according to law to make himself a citizen of the United States, this act shall have no effect to confirm his title to the property above mentioned, nor shall he, or any person claiming under him, derive any benefit under this act; but if the said Frederick Saler shall die before the time when, by the laws of the United States, he may become a citizen thereof, nothing in this proviso contained shall prevent him from transmitting or transferring his said property by descent or devise to any issue he may leave residing within the United States, who is hereby declared capable in law to hold the same, or to any other person, being a citizen of the United States, and capable in law to hold the same."
