BY THE HOUSE OF DELEGATES, NOVEMBER 16, 1801.

GENTLEMEN OF THE SENATE,

THE office of register of wills in Somerset county being vacant, we propose, with the concurrence of your house, to go into an election to-morrow at 12 o'clock. Mr. George Handy, William Winder, John Anderson and Robert Lemmon, are nominated by this house to fill this office, and we have appointed Mr. Lowes and Mr. A. Stuart, in conjunction with any members of your house, to examine the ballots.
