MONDAY, December 7, 1801.

THE senate met. Present the same members as on Saturday. The proceedings of Saturday were read. The bill, entitled, A further supplement to an act to streighten and amend the public roads in Harford county, and to repeal the act of assembly therein mentioned, was read the second time and will pass with the proposed amendment.

Amendments proposed. After the words "William Maccubbin" in the 2d line of the 1st clause, add "Daniel Stanbury."

The bill, entitled, A further supplement to the act, entitled, An act for the draining of a marsh and branch known by the name of the Long Marsh, lying in Queen-Anne's and Caroline counties, was read the second time and will pass with the proposed amendments.

Amendments proposed. Strike out the word "the" in the last line but one. Strike out the word "of" in the last line.

The resolution in favour of Patrick Murdock was read the second time, dissented from, and sent to the house of delegates by the clerk.

The resolution in favour of Elizabeth Menkey was read the second time, assented to, and sent to the house of delegates by the clerk.

The bill, entitled, An additional supplement to the act, entitled, An act to erect a town in Queen-Anne's county, was read the second time and will not pass. Sent to the house of delegates by the clerk.

The bill, entitled, An act to authorize the levy court of Saint-Mary's county to levy a sum of money for the rent of a clerk's office, was read the second time, passed, and sent to the house of delegates by the clerk.

The bill, entitled, An act to empower the late sheriff of Montgomery county to collect the balances due him, was read the second time and will not pass. Sent to the house of delegates by the clerk.

On motion, Leave given to bring in a bill, entitled, An act authorizing the removal of prisoners in certain cases. ORDERED, That Mr. Brown, Mr. Houston and Mr. Johnson, be a committee to prepare and bring in the same.

The president communicates to the senate a letter from his excellency the governor, enclosing communications from the legislature of Tennessee, respecting the amendments proposed by this state to the constitution of the United States; which were read and referred to the consideration of the house of delegates.
