

50 VOTES AND PROCEEDINGS, NOVEMBER SESSION, 1801.

The bill, entitled, An act to authorize the appointment of visitors of the gaol in Baltimore county, was read the second time, passed, and sent to the house of delegates by the clerk.

The bill, entitled, An act to alter such parts of the constitution and form of government as relate to voters, and the qualification of voters, was read the second time and will pass with the proposed amendments.

Amendments proposed. After the word "suffrage" in the 5th line of the 1st clause insert "and shall vote." Strike out the 2d clause.

Sent to the house of delegates by the clerk.

The bill, entitled, An act respecting public notaries in this state, was read the second time and will pass with the proposed amendments.

Amendments proposed. Strike out from the word "computing" in the 14th line of the 4th page to the word "fifty" in the 15th line of the 4th page and insert "one hundred and five words to a side." Strike out from the word "fees" in the 15th line of the 5th page to the word "to" in the same line. Strike out from the word "residence" in the 6th line of the 6th page to the end of the clause and insert "such notary shall be allowed not exceeding twenty cents per mile." Strike out the last enacting clause.
