THE committee to whom it was referred to consider and report whether any, and if any, what alteration are necessary to be made in the judiciary system of this state, beg leave to report, that they have had the sulk ject long under consideration, and are of opinion, that the present mode of administering justice in this state is not only attended with great inconvenience, but is frequently grievous and oppressive to the citizens thereof, by reason of having to attend the general courts at a great distance from their homes, to where not only suitors but jurors and witnesses are also obliged to attend, and such inconveniencies, in many instances, almost amount to denial of justice: And whereas by the declaration of rights of this state, amongst other things it is declared, that the trial of facts where they arise, is one of the greatest securities of the lives, liberties and estates, of the people, and that every person ought to have justice and right freely without sale, fully without any denial, and speedily without delay, and that those salutary provisions may be more fully carried into effect, and bring justice as near as may be to every man's door, your committee therefore beg leave to submit the following bill: A bill, entitled, An act to alter, change and abolish, such parts of the constitution and form of government as relate to the establishing a general court and court of appeals.
