BY THE HOUSE OF DELEGATES, DECEMBER 26, 1803.

**W**hereas it is represented to the general assembly of Maryland, that on the 11th day of July, 1802, John Schley, one of the justices of the peace of Frederick county, held an inquest on the body of a person found drowned in Monocacy, whose name or place of residence could not be ascertained, and with whom was found, by the jurors composing said inquest, the sum of eighty-three dollars specie; that the said John Schley took charge of said money, and put it into the hands of Lawrence Brengle, late sheriff of said county, to be by him accounted for, (after discharging the ordinary expences of the inquisition,) in such manner as may be deemed right; therefore **R**ESOLVED, That Lawrence Brengle, late sheriff as aforesaid, pay the balance of the said money in his hands to the trustees or visitors of Frederick county school, and which the said visitors or trustees may apply to the completion of the well, or to the repair of the school-house, or property belonging to the same, as to them shall be thought proper.
