

The clerk of the house of delegates delivers a bill, entitled, A further supplement to an act for amending and reducing into system, the laws and regulations concerning last wills and testaments, the duties of executors, administrators and guardians, and the rights of orphans and other representatives of deceased persons; a bill, entitled, An act for introducing a copious supply of wholesome water into the city of Baltimore; a bill, entitled, An act to incorporate the Marine insurance company, a bill, entitled, An act authorising Hugh Sherwood, of Huntington, to complete his collection, severally passed by that house January 3, 1805; a bill, entitled, An act to grant a public road, and confirm the same, in the upper part of Queen-Anne's county; a bill, entitled, An act for the benefit of George Ford, of Saint-Mary's county, a minor, a bill, entitled, A further supplement to an act, entitled, An act to regulate the inspection of tobacco, severally passed by that house January 4, 1805; and the following resolution:

BY THE HOUSE OF DELEGATES, JANUARY 3, 1805.

RESOLVED, That all proceedings against William Rose, James Booker and Philemon Willis, on a judgment obtained against them, as securities of William S. Bond, for the recovery of a sum of money due by the said William S. Bond to the state of Maryland, be and they are hereby suspended until the tenth day of April, eighteen hundred and eight; and the said William Rose, James Booker and Philemon Willis, be and they are hereby indulged in the payment of the said sum of money till the period before mentioned; provided, that the judgment aforesaid shall continue and be in full force, notwithstanding the suspension of proceedings directed by this resolution, and if the sum of money that will then be due on the aforesaid judgment be not paid by the time aforesaid, an execution may be issued against them, or either of them, to enforce the payment thereof.

Mr. Fossitt has leave of absence for the remainder of the session.

The bill, entitled, An act respecting certain lots of land westward of Fort Cumberland, was read the second time and will pass with the proposed amendments.

Amendments proposed. 1. After the word "empowered" in the 2d line of the 2d enacting clause insert "on the application of any person or persons in possession of a lot or lots westward of Fort Cumberland." 2. After the word "thereon" in the 4th line of the 2d enacting clause insert "and of which such persons persons is or are in the possession." 3. Strike out from the word "shall" in the 9th line of the 2d enacting clause to the word "any" in the following line and insert "have the same effect, and no other, as the adjunctions of the commissioners under the original act." 4. Strike out from the word "notwithstanding" in the 5th line from the end of the 2d page to the end of the 3d enacting clause.

The resolution in favour of William Gardiner, and others, and the resolution in favour of Charles Gardiner, and others, were severally read the second time and assented to.

The resolution in favour of James B. Sullivan was read the second time and dissented from.

On motion, ORDERED, That Mr. M'Culloch be added to the committee appointed to compare and examine engrossed bills.

SATURDAY, January 5, 1805.

THE senate met. Present the same members as on yesterday, except Mr. M'Culloch and Mr. Fossitt. The proceedings of yesterday were read.

The bill, entitled, A further supplement to an act, entitled, An act for the relief of the poor of Cecil county, was read the second time and will pass with the proposed amendment. Sent to the house of delegates by the clerk.

Amendment proposed. Strike out from the word "next" in the 1st line of the 3d page to the word "and" in the following line.

The bill, entitled, An act authorising Hugh Sherwood, of Huntington, to complete his collection, was read the second time by especial order and will pass. Sent to the house of delegates by the clerk.

The resolution in favour of Nathan Harrington and William Marsh Catrop, and the resolution in favour of Benjamin Chambers, were severally read the second time and assented to. Sent to the house of delegates by the clerk.

The bill, entitled, An act to enlarge further the powers of the trustees of the poor in the several counties therein mentioned, was read the second time and will pass. Sent to the house of delegates by the clerk.

The bill, entitled, An act to lay out and open a road in Anne-Arundel county, was read the second time and will pass with the proposed amendments. Sent to the house of delegates by the clerk.

Amendments proposed. 1. Strike out from the word "the" in the 5th line of the 1st page to the letter "d" in the following line and insert "persons who shall or may subscribe as herein after directed." 2. Strike out from the word "opened" in the 14th line same page to the word "and" in the same line. 3. Strike out from the word "money" in the 5th line 4th page to the word "to" last mentioned in the same line.

The resolution in favour of William Rose, James Booker and Philemon Willis, was read the second time by especial order and assented to with the proposed amendments. Sent to the house of delegates by the clerk.
