GENTLEMEN OF THE SENATE,

WE have considered the amendments proposed by you to the bill to authorise the drawing of a lottery in the tity of Baltimore for the purpose therein mentioned. We have concurred with the first amendment, but for reasons satisfactory to us have dissented from the second. We have come to this determination because the sum contemplated to be raised by the petition amounts to twelve thousand dollars, exclusive of all expences or incidental charges attending the operations of the lottery; whereas by the bill, as amended, only the gross sum welve thousand dollars will be authorised to be raised.
