years, and in case of any purchase made by the corporation of Baltimore, which they are hereby authorised to make of the said company, with their consent, at or before the said term of thirty years shall expire, of the rights conferred by this and the original act, a full and fair compensation shall be allowed to the said company for-all their property and machinery of every kind, to be adjudged and valued by twelve indifferent persons, of whom the company shall choose one half and the mayor and city council the other. And be it enacted, That the water company aforesaid shall insert, or grant permission to the corporation of Baltimore to insert and repair, at the expence of the city, such a number of fire plugs, as to them shall appear necessary, into the pipes used to convey the water through the streets thereof, to be used only in case of fire, but free from any charge for a supply of water."

The senate adjourns until to-morrow morning 9 o'clock.
