game clerks." 9. Strike out the words "shall be" in the third line of the 33d page and insert "has been."

10. After the word "court" in the last line of the 34th page insert "And be it enacted, That it shall and may be lawful for any judge of any district, or any justice of the peace in the several counties of this state, to take the bond or recognizance of any coroner, in the same manner, and shall have the same effect and operation, as bonds or recognizances heretofore taken by a chief justice of any district, or any associate justice of any county."

11. After the word "notwithstanding" in the last line of the 36th page insert. "And be it enacted, That from and after the passage of this law, it shall not be lawful for any attorney, clerk, sheriff, or other officer, of any of the courts of this state, to send out his or their fees in tobacco, as heretofore practised by the officers aforesaid, but that all fees sent out by either of them, shall be in pounds, shillings and pence. 12. Strike out the last enacting clause.

The senate adjourns until to-morrow morning 9 o'clock.

The bill, entitled, An act to authorise and empower the levy court of Baltimore county to assess and levy a sum of money for the purpose therein mentioned, was read the second time and will not pass. Sent to the house of delegates by the clerk.

On motion, ORDERED, That the bill, entitled, An act to withdraw the funds from Washington and SaintJohn's colleges, and subject the same to the appropriation of the legislature, have a second reading on Tuesday
next, the fourteenth instant.

The bill, entitled, An act for the relief of Richard Gittings and Lambert Smith, of Baltimore county, in solvent debtors, was read the second time, and the question put, Shall this bill pass? The year and nays being required, appeared as follow:
