T U E S D A Y, January 14, 1806.

THE senate met. Present the same members as on yesterday. The proceedings of yesterday were read. The clerk of the house of delegates delivers a bill, entitled, An act authorising the chancellor in certain cases to decree conveyances for land the title to which is in British subjects, a bill, entitled, An act compelling the proprietors of lots binding on the water at the west end of the basin in the city of Baltimore to extend and improve the same, severally passed by that house January 13, 1806; and the following resolutions:

By the H O U S E of D E L E G A T E S, January 13, 1806.

RESOLVED, That the auditor be and he is hereby authorised and required to examine, and report to the general assembly, what sum of money, if any, is due to William Amos, senior, of Harford county, on account of expences incurred by him in superintending the execution of a commission which issued in behalf of the state, at the instance of the intendant, to settle the lines of a tract of land, lying in Harford county, called The Grove, whereby the state has been very materially benefitted.

By the H O U S E of D E L E G A T E S, January 13, 1806.

RESOLVED, That the governor and council be and they are hereby authorised to direct that the suit instituted at the instance and for the use of the state, in the late general court of the eastern shore, against Daniel Sheredine, a security for a certain Letitia Crookshanks, administratrix of a certain John Crookshanks, late of Cecil county, deceased, who in his life-time was a security of a certain Patrick Hamilton, a former sheriff and collector in said county, be struck off and discontinued upon the payment, by the said Daniel Sheredine, of all costs which have accrued in said suit, and that the claim against the said Daniel Sheredine shall be thereafter cancelled.
