The clerk of the house of delegates delivers the bill, entitled, An act relating to the inspection of tobacce not the growth of this state, rejected by that house January 21, 1806; a bill, entitled. An additional supplement to an act, entitled, An act to erect Baltimore-town, in Baltimore county, into a city, and to incorporate the inhabitants thereof, passed by that house January 20, 1806; and the following resolution:

Br THE HOUSE or DELEGATES, January 22, 1806.

Resolven, That the agent, Joseph H. Nicholson, pay over to the treasurer of the western shore; the cash received, or which shall be received, from the sales of British stock, or from dividends on said stock, and the said agent shall receive the same commission thereon as if the amount had been transmitted in stock of

the United States, pursuant to the resolutions passed November session, eighteen hundred and four.

Whereas the state bath heretofore become a stockholder in the Bank of Baltimore to the amount of one hundred and six thousand two hundred dollars, in the Union Bank of Maryland to the amount of forty-two thousand four hundred dollars; and in the Farmers Bank of Maryland to the amount of forty thousand dollars : And whereas it is intended to vest in stock of the said banks the further sum of three hundred and eleven thousand three hundred dollars, and this general assembly, always solicitous to cherish and protect the interest of the farmers, planters and mechanics, as well as to promote the interest of the commercial partiof the citizens, convinced that the Farmers Bank of Maryland, being established for the benefit of the farmers, planters and mechanics of our country, merits, and ought to receive from the state, a patronage equal at least to that afforded to any other bank; in order therefore that the aid and countenance of the state to each of the banks aforesaid shall be equal, the aforesaid sum of three hundred and eleven thousand three hundred dollars shall be aps portioned among the said banks agreeable to the following resolution: Resolved; That the treasurer of the western shore, under the direction of the governor and council, subscribe, on the part of this state, in the Bank of Baltimore the sum of sixty thousand three hundred dollars, in the Union Bank of Maryland the sum of one hundred and twenty-four thousand three hundred dollars; and in the Farmers Bank of Maryland the sum of die hundred and twenty-six thousand seven hundred dollars, the amount of which subscriptions shall be paid
