wided always, that if any person or persons through or on whose lands said road shall pass, or his, her or their guardian or trustee, shall conceive themselves aggrieved by such valuation and assessment of damages by the said commissioners, it shall and may be lawful for any justice of the peace of said county, upon the application of the person or persons so aggrieved, to issue his warrant to the sheriff of the county, commanding him to summon twelve freeholders of said county, not interested in the premises, and qualified to serve as jurors, to appear on a day by the said justice to be appointed, on the premises; and the said sheriff is hereby authorised to administer an oath to the persons so summoned; that they will, without favour, affection, prejudice or partiality, assess the damages sustained by the person or persons at whose request such inquisition shall be taken, by reason of opening the aforesaid road through or on his, her or their lands; and the persons so summoned and sworn shall thereupon proceed to assess and value the damages accordingly, of which the said commissioners, or a majority of them, shall have at least five days previous notice, and shall return the damages so assessed to, the county court of said county; and such inquisition shall be final and conclusive, and the said valuation or damages shall be paid to the parties respectively entitled to the same, before the said commissioners shall proceed to open said road."

The bill, entitled, An act authorising a lottery for raising a sum of money for the use and benefit of the Gha. ritable Marine Society of the city of Baltimore, was read the second time, passed with the proposed amend.
