RESOLVED, That his excellency the governor deliver up to the said Joseph H. Nicholson, or his order, the bond given by him for the faithful discharge of his duty as agent aforesaid, on his paying into the treasury the sum of twelve hundred and twenty-four dollars and eight cents. 'All which is submitted.

F R I D A Y, December 5, 1806.

HE senate met. Present the same members as on yesterday. The proceedings of yesterday were read. The senate proceeded to the election of a member to fill the vacancy occasioned by the death of Mr. Thomas Duckett, and after qualifying according to the constitution and form of government, the ballot box being prepared, and the ballots deposited therein, on examination thereof it appeared that Dr. William Somervell had a majority of votes. Whereupon it is declared in the senate, that Dr. William Somervell, having had a majority of votes, is duly elected a member of the senate.

The bill, entitled, A further additional supplement to an act, entitled, An act to regulate the inspection of

tobacco, was read the second time, passed, and sent to the house of delegates by the clerk.

The clerk of the house of delegates delivers a bill, entitled, A supplement to an act, entitled, An act to alter the mode of collecting the county tax in Harford county, passed by that house December 5, 1806; which was read the first time and ordered to lie on the table.

The clerk of the house of delegates delivers the bill, entitled, An act authorising the justices of the orphans

courts to take sheriffs bonds, with the following message:

By the HOUSE of DELEGATES, December 4, 1806.

Gentlemen of the Senate,

WE return the bill, entitled, An act authorising the justices of the orphans court to take sheriffs bonds, after having dissented to the amendment proposed by you. We are still of opinion, that the manner of taking those bonds should be as uniform as possible, which object will be defeated by adopting the amendment; and while we are not disposed to lessen the powers already vested in the judges of the county courts, we apprehend the instances in which they would be applied to on this subject would be very rare, and that the whole duty, from convenience and expediency, would devolve on the justices of the orphans court, who would be the better judges of the competency of the security offered for the due performance of the duties of the sheriffs respectively.

If you should be of opinion with us, as to the preference of taking the bonds by the justices of the orphans court, we beg leave to suggest, that an amendment proposed by you, giving them the exclusive power, would pass this house, rather than the present inconveniencies should be longer submitted to. We therefore solicit a reconsideration of the subject, in expectation that our wishes may be gratified in the passage of the bill, either

without insisting on your amendment, or with such a modification as we have suggested.
