The bill, entitled, An act to alter the time of holding the county court in Worcester county, was read the second time, passed, and sent to the house of delegates by the clerk.

The clerk of the house of delegates delivers a bill, entitled, An act to prohibit the emigration of free negroes into this state, passed by that house December 24, 1806; a bill, entitled, An act supplementary to the act for erecting a town in Talbot county, and to the act for the regulation and improvement of Easton, a bill, entitled, An act to continue certain acts of assembly, a bill, entitled, An act to lay out and open an old road in Harford county, a bill, entitled, An act to condemn a piece of ground in Kent county for the purposes therein mentioned, a bill, entitled, An act relating to orphans, a bill, entitled, An act to prevent persons from retailing spirituous liquors within a certain distance of any place of religious worship, except as is therein excepted, severally passed by that house December 26, 1806, and the following resolution:

By the HOUSE of DELEGATES, December 24, 1806.

Resolved, That the treasurer of the western shore be and he is hereby authorized and required, to pay unto James Lawrence, or to his order, the amount of one year's pay as a seaman in the service of the United States during the revolutionary war, out of any unappropriated money in the treasury.
