The bill, entitled, An act annulling the marriage of James W. Dimmett and Catharine Dimmett, was read the second time by especial order and will pass.

The senate adjourns until to-morrow morning 9 o'clock.

F R I D A Y, January 2, 1807.

THE senate met. Present the same members as on yesterday. The proceedings of yesterday were read. Mr. Williams appeared in the senate.

The bill, entitled, An act annulling the marriage of James W. Dimmett and Catharine Dimmett, and the engrossed bills from 1 to 30, inclusive, were sent to the house of delegates by the clerk.

The bill, entitled, An act to authorise the levy court of Montgomery county to assess and levy a sum of money for the purpose therein mentioned, the bill, entitled, A supplement to an act, entitled, An act to prevent any obstruction of the navigation in the river Patowmack, were severally read the second time, passed, and sent to the house of delegates by the clerk.

The bill, entitled, An act to encourage the destruction of crows in the several counties of this state, was read the second time and will not pass. Sent to the house of delegates by the clerk.

The resolution in favour of Joseph Ennals, and others, was read the second time, assented to with the proposed amendment, and sent to the house of delegates by the clerk.

Amendment proposed. At the end of the resolution add, "provided that nothing herein contained shall prevent an execution or executions being issued, after the said first day of December."

The bill, entitled, An act to lay out and open a public road in the direction herein after mentioned in Baltimore county, was read the second time, passed, and sent to the house of delegates by the clerk.

The bill, entitled, An act to lay out and make public a road in Charles county, was read the second time, by especial order, passed, and sent to the house of delegates by the clerk.

The resolution in favour of Jubb Fowler, was read the second time, dissented from, and sent to the house of delegates by the clerk.

The following message was read, agreed to, and sent to the house of delegates by the clerk.

By the S E N A T E, January 2, 1807.

The clerk of the house of delegates delivers a bill, entitled, An act to lay out and straighten a road from Towson's tavern, on the Baltimore turnpike road, to intersect the Pennsylvania line at Major David Wiley's, passed by that house January 2, 1807; a bill, entitled, An act making compensation to the criers of the court of appeals, and the sheriffs attending the said courts for the preservation of order therein, a bill, entitled, An act authorising the levy courts of Anne-Arundel and Prince George's counties to levy a sum of money for building a bridge over Patuxent river, at Queen-Anne, a bill, entitled, An act to alter such parts of the constitution and form of government as relate to voters and qualifications of voters; a bill, entitled, A supplement to an act, entitled, An act respecting the acknowledgment of deeds; a bill, entitled, An act authorising the collection of certain ground-rents due on lots in the town of Cumberland, in Allegany county, severally passed by that house January 2, 1807; which were severally read the first time and ordered to lie on the table.

The bill, entitled, An act annulling the marriage of Benjamin Ferguson and Ruth his wife, of Cecil county, was read the second time, passed, and sent to the house of delegates by the clerk.

The bill, entitled, An act making an addition to the name of Thomas Porter, of the city of Baltimore, was read the second time by especial order and will not pass. Sent to the house of delegates by the clerk.

The resolution relative to the government-house, was read the second time, assented to, and sent to the house of delegates by the clerk.

The clerk of the house of delegates delivers a bill, entitled, An act for the encouragement of learning in this state, passed by that house January 2, 1807; which was read the first time and ordered to lie on the table.

The bill, entitled, An act annulling the marriage of Sally Lutig and John C. Lutig, was read the second time, passed, and sent to the house of delegates by the clerk.

The resolution in favour of Cornelius Manning was read the second time, dissented from, and sent to the house of delegates by the clerk.

The bill, entitled, An act to alter such parts of the constitution and form of government as relate to voters, and qualifications of voters, was read the second time, by especial order, and will not pass. Sent to the house of delegates by the clerk.

The clerk of the house of delegates delivers a bill, entitled, An act authorising a lottery in the city of Baltimore to raise a sum of money for the purposes therein mentioned, passed by that house December 31, 1806;
