Resolved, That all proceedings against John Wilkins, and his securities, on a judgment obtained against them on account of a balance due to the state by the said John Wilkins, as sheriff of Sometset county, be and are hereby suspended until the first day of January, eighteen hundred and nine, and also that the said John Wilkins, and his securities, be and they are hereby released from the payment of the nine per cent, per annum, of the said John Wilkins, and his securities, shall punctually pay to the treasurer of the eastern shore, on or before the first day of January, eighteen hundred and nine, the principal of the balance due the state, with interest on the same, at the rate of six per cent, per annum, together with all costs on said judgment; provided, that the judgement aforesaid shall continue and be in full force, notwithstanding the suspension directed by this resolution, and that if the said John Wilkins, and his securities, shall fail in the said payment; they shall thereby forfeit the benefit of this resolution, and shall be liable to be proceeded against immediately for the whole of the said debt and costs and the fifteen per cent, interest now payable thereon.
