

26 VOTES AND PROCEEDINGS, NOVEMBER SESSION, 1807.

The clerk of the house of delegates delivers a bill, entitled, An act to incorporate a Fire Insurance Company in the city of Baltimore, a bill, entitled, An act to quiet the possessions and fix the lines of the lots of ground fronting on the west side of Philpot street, between White street and Thames street, in the city of Baltimore, a bill, entitled, A further supplement to an act, entitled, An act to incorporate an Insurance Company in Baltimore town, a bill, entitled, An act for the relief of Nathaniel Chew, Peter Miles and Robert Nesbit, Baltimore county, severally passed by that house December 21, 1807; a bill, entitled, An act for the relief of Mary Gwynn, of Frederick county, a bill, entitled, An act to lay out and open a road in Frederick county, severally passed by that house December 22, 1807; and the following resolutions:

RESOLVED, That all proceedings against Denwood Hicks and William Ennalls, and their securities, on judgment obtained by this state against them, for the purchase money due on the Choptank Indian lands, be and the same are hereby suspended and stayed until the first day of January, 1810.
