T U E S D A Y, January 5, 1808:

THE senate met. Present the same members as on yesterday, except Mr. Somervell, who is indisposed. The proceedings of yesterday were read.

The bill, entitled, An act for the benefit and relief of John Hebb, of St. Mary's county, the bill, entitled, An act for the relief of Anne Terry, of Kent county, the bill, entitled, An act for the relief of Henry Waller, of Kent county, the bill, entitled, An act authorising a lottery to raise a sum of money for the vestry of St. John's parish, in Harford and Baltimore counties, the bill, entitled, An act to confirm a certain road in Baltimore county, and the bill, entitled, An act for the relief of Nathaniel L. Chew, Peter Miles and Robert Nease, of Baltimore county, were sent to the house of delegates by the clerk.

The bill, entitled, An act for the relief of Notley Maddox, sheriff of Prince-George's county, was read the second time and will not pass. Sent to the house of delegates by the clerk.

The resolution in favour of Jeremiah T. Chase, chief judge of the third judicial district, was read the second time and dissented from, and sent to the house of delegates by the clerk.

The bill, entitled, A further supplement to the act, entitled, An act authorising Thomas Bailcy, late sheriff collector of Baltimore county, to complete his collection, and for other purposes, and the bill, entitled, A further supplement to an act, entitled, An act to alter the mode of collecting the county tax in Harford county, were severally read the second time and will not pass. Sent to the house of delegates by the clerk.

Mr. McElderry, from the committee, delivers a bill, entitled, A further supplement to the act, entitled, An act to incorporate companies to make several turnpike roads through Baltimore county, and for other purposes; was read the first time and ordered to lie on the table.

The clerk of the house of delegates delivers a bill, entitled, An act to confirm a certain road therein mentioned; a bill, entitled, An act annulling the marriage of Joseph Boyd, and Elizabeth his wife, severally passed by that house January 4, 1808; a bill, entitled, An act to pay the civil list, and other expenses of civil government, by that house January 5, 1808; which were severally read the first time and ordered to lie on the table.

The bill, entitled, An act authorising a lottery to raise a sum of money to purchase a fire engine, and finish a church in Westminster town, in Frederick county, was read the second time by especial order, passed with the proposed amendment, and sent to the house of delegates by the clerk.

Amendment proposed. After the word "Yingling" in the 12th line of the 1st page insert "or a majority of them." The bill, entitled, An act for the relief of Martin Brown, an insolvent debtor, of St. Mary's county, was read the second time, passed with the proposed amendments, and sent to the house of delegates by the clerk.

Amendments proposed. 1. Strike out the preamble. 2. Strike out from the word "laws" in the 7th line of the 2d page to the end of the bill and insert "in as full and ample a manner as if the said Martin Brown had been named in said laws."

The bill, entitled, An act to lay out and make public an old road in Harford county, was read the second time by especial order and will not pass. Sent to the house of delegates by the clerk.

The bill, entitled, A supplement to an act, entitled, An act for the relief of John Booth, and for confirming title in certain lands therein mentioned, was read the second time, passed, and sent to the house of delegates by the clerk.

The clerk of the house of delegates returns the bill, entitled, An act for the relief of Robert Leatherbury, sheriff of Somerset county, with the following message:

Gentlemen of the Senate,
