The clerk of the house of delegates returns the bill, entitled, An act to provide for the making passable through Baltimore county the public road laid out from the city of Baltimore to the town of Belle-Air, in Harford county, endorsed, "will pass with the proposed amendments," which were read.

THE senate met. Present the same members as on yesterday. The proceedings of yesterday were read. Mr. Somervell appeared in the senate.

The bill, entitled, An act authorising Elizabeth Sherwood and Thomas Banning, administrators of Hugh Sherwood, of Huntington, deceased, to complete the collection of balances due the said Sherwood as sheriff of Talbot county, was sent to the house of delegates by the clerk.

The clerk of the house of delegates delivers a bill, entitled, An act to incorporate the contributors to the Baltimore General Dispensary, a bill, entitled, An act to authorise the levy court of Anne-Arundel county to assess and levy a sum of money for the purposes therein mentioned, a bill, entitled, An act to release to Richard Trimble the right of the state of Maryland to the property therein mentioned, severally passed by that house January 5, 1808; which were severally read the first time and ordered to lie on the table.

The bill, entitled, An act for the relief of Samuel Thomas, James Colston, and Benjamin Benny, executors of Charles W. Benny, deceased, securities of Philemon Willis, late sheriff of Talbot county, was read the second time, passed with the proposed amendment, and sent to the house of delegates by the clerk.

Amendment proposed. Strike out from the word "county" in the 4th line of the 2d page to the word "for" in the 5th line of the same page.

The clerk of the house of delegates delivers a bill, entitled, An act to lay out and open a road from Bond street, on Fell's Point, to intersect the York turnpike road, a bill, entitled, An act to authorise a lottery to raise a sum of money for the purpose of finishing the Elkton academy, purchasing philosophical apparatus for the same, and for paving and improving the streets of Elkton, in Cæcil county, a bill, entitled, An act to lay out, straighten and amend, an old road in Harford county from the Maryland line to Isaac Davis's, severally passed by that house January 6, 1808; which were severally read the first time and ordered to lie on the table.

The bill, entitled, An act to make public a road in Charles county, was read the second time, passed with the proposed amendments, and sent to the house of delegates by the clerk.

Amendments proposed. 1. Strike out the words "William H. M'Pherson" in the 11th line of the 1st page and insert "Walter Dyson." 2. Strike out the words "Samuel Chapman" in the 12th line of the 1st page and insert "William Wood." 3. After the word "church" in the 14th line of the 2d page insert "provided, that the said commissioners shall deem it more convenient and advantageous to locate the said road otherwise than as herein designated, they shall have full power and authority to vary the courses of the same at their discretion."

On motion, the question was put, Will the senate reconsider the bill, entitled, An act for the relief of Robert Leatherbury, late sheriff of Somerset county? Determined in the negative, and, with the following message, sent to the house of delegates by the clerk.
