RESOLVED, That from and after the present session of assembly, no private act shall pass the legislature up on any petition or application whatever, unless notice is given by the petitioners, or applicants, in some news: paper printed in the city of Baltimore, for — successive weeks, and by advertising at the court-house door of the county where such petitioners or applicants reside, at least — weeks before the meeting of the general assembly to which such application is to be made, that a petition is intended to be preferred, mentioning in such notice the substance of such petition; and that evidence of the notice be produced upon hearing such petition.
