hood on shore, or else has exiled into foreign employ in quest of sustenance and support; that it has me the faith of individual credit, frustrated the hopes of labour, disappointed business of its profits, depressi pulse of industry, and continues to inflict loss and deprivation throughout the great body of community that there is sad reason to apprehend that this evil, already so productive of mischief, unless it is timely me ed and removed, may eventuate in consequences the most awful, calamitous and irretrievable. Wherefore

RESOLVED, That the senators and representatives from this state in the congress of the United States be an they are hereby earnestly requested, to exert themselves with all convenient diligence in endeavours to procue a speedy relief from the operation of the aforesaid act, passed at the last session of congress, imposing and
