The speaker, attended by the members of the house of delegates, appeared in the senate room, and Edward Lloyd qualified as governor before the president of the senate, in the presence of both houses, by taking oaths directed by the constitution and form of government, the oath of office prescribed by law, and by take an oath to support the constitution of the United States, and also by subscribing a declaration of his belief the Christian religion.

The clerk of the house of delegates returns the bill, entitled, An act to alter the thirty-second article of the constitution and form of government, endorsed, " By the house of delegates, June 9, 1809: Read the second
