By the HOUSE of DELEGATES, January 5, 1810.

Whereas the several acts of assembly of this state relating to, and for the regulation of, officers fees, are del fective, and in some respects doubtful, as to what is the true intent and meaning of the same: And whereas it is proper and necessary that the general assembly should possess such information on those subjects as will enable them to remedy the same; therefore Resolved, That the register in chancery, the registers of the landoffices, and the clerks of the courts of appeals for the western and eastern shores, the clerks of the county courts, the registers of wills, and the sheriffs, in the several counties of this state, be and they are hereby severally requested, to make out and lay before the general assembly, at the next November session, a billion account of fees properly chargeable for services performed in their respective offices, so as to shew what changes or further regulations it might be proper for the legislature to provide; and in making out such bill or account of fees, to make the same as concise and plain as practicable, and to have as few items as possible, so as to include the services aforesaid; and that each of the clerks of the several county courts, the clerks of the courts of ap. peals, and the register of the court of chancery, make out and lay before the next general assembly the number of suits that have been brought to, or instituted in, and also the number that have been determined, dismissed or disposed of, by the said courts respectively, within each year, for three years prior to the first day of Sep. tember, eighteen hundred and ten.

RESOLVED, That the register in chancery make out the number of suits depending in the court of chancery, the respective periods when the same were brought, and the different counties or places of residence of the de-

fendants in the said causes, so far as he can ascertain the same.

RESOLVED, That the clerk of the house of delegates be and he is hereby directed to forward to each of the aforesaid officers a copy of those resolutions. J. BREWER, clk.

Jacob, late of Allegany county, now of Virginia, as lieutenants, or to their orders respectively, such a sum of money annually, as is equal to half of the pay to which they were respectively en, titled during the revolutionary war, agreeable to their respective ranks.

RESOLVED, That the treasurer of the western shore be and he is hereby directed to pay to Rezin Simpson, of Allegany county, as a sergeant of the horse, Oliver Lindsey, of Frederick county, as a corporal, John Will Hams, of Saint-Mary's county, as a corporal, and William Ahorn, of Frederick county, William Horney, of Talbot county, Henry Spalding, of Saint-Mary's county, Francis Johnson, of the city of Baltimore, William Dawson, Thomas Gadd, of Queen-Anne's county, and James Maxwell, of Cæcil county, Jacob Allen, now of the state of Desaware, William Sewell, of Anne-Arundel county, James Dorell, of Queen-Anne's county, and William Pierce, now of the state of Virginia, and John Page, as privates in the late revolutionary war, or to their orders respectively, in half yearly payments, a sum of money equal, annually, to the half pay

to which they were respectively entitled for their services during the said war.
