The clerk of the house of delegates delivers a bill, entitled, An act to preserve the breed of fish in Baltiand sent to the house of delegates by the clerk. more county, a bill, entitled, A supplement to an acl, entitled, An acl to authorise a lottery to raise a sum of money for repairing the Protestant Episcopal Church in the city of Annapolis, a bill, entitled, An acl annulling the marriage of Abraham Parks, and Eleanor his wife, severally passed by that house November 28, 1810; which were severally read the first time and ordered to lie on the table. Also returns the bill, entitled, An act for the relief of George Stine, of the city of Battimore, passed by that house November 28, 1810. Ordered that the said bill be engrossed. And delivers the following message:

By the HOUSE of DELEGATES, November 28, 1810.

WE propose, with the concurrence of your house, to proceed this day, at 12 o'clock, to an election of two directors on the part of this state for the Union Bank of Maryland. Mr. Elias Glenn, Mr. James Caldwell and Mr. George A. Hughes, are put in nomination by this house, and Mr. Forwood and Mr. Wharton, are appointed on the part of the house of delegates, to join such gentlemen as may be named by you, for the purpose of examining the ballots; and for regulating said election we have adopted the following resolution:

RESOLVED, That the person or persons having a majority of the ballots of all the attending members of both

branches of the legislature, shall be the director or directors of the said bank.

The bill, entitled, An act to confirm an act passed at November session, eighteen hundred and nine, entitled, Which was read. An act to alter and abolish all such parts of the constitution and form of government as require a property qualification in persons to be appointed or holding offices of profit or trust in the state, and in persons elected members of the legislature, or electors of the senate, was read the second time, passed, and sent to the house of delegates by the clerk.

By order, The bill, entitled, An acl to confirm to Lewis Grant Davidson, of the city of Baltimore, the surname of Davidson, was read the second time by especial order, passed, and sent to the house of delegates by the clerk-

The senate proceeded to the election of two directors, on the part of the state, in the Union Bank of Maryland; the ballot box being prepared, and the ballots deposited therein, the committee appointed by the senate to meet the committee appointed by the house of delegates, retired to the conference room, and after some time returned and reported, that James Caldwell had seventy votes, Elias Glenn forty-seven votes, and

Whereupon it is declared in the senate, that James Caldwell and Elias Glenn, having had a majority of the George A. Hughes twenty-six votes. votes of all the attending members of both branches of the legislature, are duly elected directors on the part of

the state in the Union Bank of Maryland.

The senate adjourns until to-morrow morning 9 o'clock.
