same shall have been concluded, for confirmation or rejection.

RESOLVED, That the governor of this state be requested to transmit, without delay, to the governor of Vir Binia, a copy of the foregoing resolve, in order to its being laid before the legislature of that commonwealth and at the same time to communicate the wish of this general assembly that a similar resolve may be passed J.
