At the end of the bij add " provided that thirty feet of the said wharves, when so made out and extended, at the end thereof parallel. with Lee street, shall be deemed, taken and considered; as a public highway for ever thereafter, reserving nevertheless to the proprietors of the said wharves the benefit and advantage of the wharfage thereof."
