and open a road in Prince George's county, and for other purposes, were read the second time, passed and sent to the senate.

The amendments proposed to the Supplement to the act of seven teen hundred and eighty-five, and the supplementary acts thereto, which provide for the poor of Dorchester county, were read,

agreed to, and the bill ordered to be engrossed.

On motion by Mr. T. Johes, leave given to bring in a bill entitled, A supplement to an act entitled, An act author sing a lottery to raise a sum of money for the purpose of making a permanent bridge over the river Monoeacy, in Fre erick county. Ordered, that Messrs. T. Jones, Swearingen and Shriver, be a committee to prepare and bring in the same.

Mr. Jackson delivers a petition from Charles Farrow, of Somerset county, praying for a special act of insolvency; which was

read and referred to Messrs. Jackson, Long and Waller.

Mr. Reynolds delivers a bill entitled, An act for the relief of

Richard Mackall, junr. of Calvert county; which was read.

The clerk of the senate delivers the bill to pay the civil list and other expenses of civil government; the bill for the relief of Levin Carey, of Worcester county; and the bill for the benefit of the vestry of St. George's parish, in Harford county, severally endorsed "will pass;" ordered to be engrossed. The bill for the appointment, by the people, of the justices of the levy courts, in the several counties of this state, endorsed, "will not pass;" also, a bill entitled, An act to alter the time of the meeting of the General Assembly of this state, and for other purposes; and a bill entitled, A supplement to the act entitled, An act to incorporate the stock-holders of the Commercial and Farmers' Bank of Balmore, severally endorsed "will pass;" which were severally read And the resolution in favor of Henry Reading, endorsed "as sented to.

Mr. Emerson delivers a petition from Edward Reynolds, Esq. (of Thomas Reynolds) and Richard Mackall, surviving executors of Benjamin Mackall, of Calvert county, praying that judgments obtained against William and Robert Mollison, whose property was confiscated by the state, may be paid; which was read and

referred to Messrs. Emerson, Herbert and Bowles.

The bill authorising the levy court of Baltimore county to appoint supervisors on the roads therein mentioned, and to repeat the act entitled, An act relating to the criminals in Baltimore county, was read the second time. On motion by Mr. Sanders that the following be added to the bill. viz.: "And be it enacted, that the levy court of Baltimore county at their next levy, shall assess and levy on the assessable property of said county, the sum of

dollars for the purpose of cleaning and making good that part of the Belle Aire road lying between the Little Falls of Gunpowder, and Jeffery's tavern in Baltimore county." The question was put, That the blank therein be filled up with the words three hundred?" Resolved in the affirmative. The question was
