The supplement to the act entitled, An act authorising the justices of the levy court of Baltimore county to lease and exchange the property therein mentioned. The bill for the relief of Sater T. Walker. The bill to lay out a road from Hanson Haddaways land to the main road leading from Easton to Knapp's Narrows, in Talbot county. The bill for the relief of the heirs of James Cain, late of Harford county, deceased. The bill for the relief of Wealthy Beachbord, of Worcester county, and her infant children. The bill to lay out and open a road in Worcester county, and the supplementary act relating to insolvent debtors, severally endorsed, "will pass;" ordered to be engrossed. And the bill for the relief of James Cruickshanks of Kent county, endorsed, "will pass with the proposed amendment;" which amendment was read, agreed to and the bill ordered to be engrossed.
