THE Committee to whom was referred the petition of Isaac Perryman of Harford county, report, That they have taken the same into consideration, and find that the said Isaac Perryman did, on or about the thirteenth day of November in the year eighteen hundred and nine, discover on his farm two negroes named John and Charle, which he supposed to be runaways; that the said negroes were severely frost-bitten, so much so that they could not be removed to the county gaol for the space of one month; that during the whole of said time the said negroes were taken care of, nursed and fed at the expense of said Perryman; that as soon as the said negroes were in a situation to be carried to the common gaol of the county they were removed; that the said negroes, it was found, had made their escape from the vessel which carried them to Baltimore before they were delivered to the officer authorised to receive them for the purpose of conveying them to the wheelbarrow, they having been condemned fourteen years each by Queen Anne's county court to said punishment.
