

redeem certain paper money in his possession, issued at different times from 1767 to 1774, notwithstanding the limitation heretofore made to such claims; which was read and referred to Messrs. Randall, Barney and Stansbury.

The bill to change the place of holding the election in the third election district, in Cecil county, and for other purposes, was read the second time and passed.

Mr. Stansbury delivers a memorial from James Bosley and others, counter to the petition of Phillip German, Junr. an insolvent debtor; which was read and referred to the general committee on insolvent petitions.

Mr. Sanders delivers a petition from Thomas M. Forman, of Cecil county, praying that a law may pass to confirm his title to certain lands therein mentioned; which was read and referred to Messrs. Sanders, Evans and Plater.

Mr. Lecompte from the committee delivers a bill entitled, An act for the benefit of Thomas Coleston, of Dorchester county; which was read.

Mr. Stevens delivers a bill entitled, An act annulling the marriage of Robert Offley and Sarah his wife, of Queen Ann's county; which was read.

The house adjourns until Monday morning 9 o'clock.

### MONDAY, November 23, 1812.

THE House met.—Present the same members as on Saturday.—The proceedings of Saturday were read.

Mr. Lewis appeared in the house.

The bill to change the place of holding the election in the third election district of Cecil county; the bill for the relief of John Mitchell, Senr. and Richard Dove, of Prince George's county; the bill to appoint commissioners to review the road from New-Bremen to New-Market, in Frederick county; the resolutions relative to the stock of this State; the resolution for clothing the Militia; and the resolution in favor of John Chance and John Watkins, were sent to the senate.

Mr. Lewis delivers a petition from Benjamin Yoe and Mary his wife, of Washington county, praying that a law may pass, authorising them to sell certain lands belonging to the heirs of Thomas Helm; which was read and referred to Messrs. Lewis, Wm. B. Williams and Sprigg.

The bill entitled, A further supplement to the act entitled, An act to facilitate the draining of land in the several counties therein mentioned, was read the second time, passed and sent to the senate.

On motion by Mr. Stansbury, leave given to bring in a bill entitled, A supplement to the act entitled, An act to authorise the levy court of Baltimore county, to assess and levy on the assessable property of said county, a sum of money to build a bridge over the Great Falls of Gun-powder. *Ordered*, That Messrs. Stansbury, Warner and Randall, be a committee to prepare and bring in the same.

The clerk of the senate delivers a report from the president and visitors of the Frederick-Town Academy; which was read; and the bill for the relief of John Tobin, of the city of Baltimore, endorsed, "will pass;" ordered to be engrossed.

The bill entitled, An act for the benefit of Airy Jump, Joshua Jump, Elijah Jump and Shelby Jump, of Caroline county, was read the second time, passed and sent to the senate.

Mr. Sanders from the committee delivers a bill entitled, An act to make valid a deed from Thomas W. Caule to Lambert Veazy, for a tract of land called Wheeler's Point, lying in Cecil county, and to confirm to Thomas Marsh Forman, his title to said land; which was read.

The house resumed the consideration of the third section of the bill for the valuation of real and personal property in this State.
