On motion by Mr. Lecompte, the question was put, That the following section be added to the bill "BE IT ENACTED, That the act entitled, An act to secure the collection of duties impose upon marriage licences, passed at November session 1797, be, and the same is hereby repealed?

Determined in the negative.

On motion by Mr. Wilson the question was put, That the following section be added to the bill; "AND BE IT ENACTED, That this act shall commence and be in operation from the first day of April next?" Resolved in the affirmative.

On motion by Mr. Lecompte the question was put, That the following section be added to the bill "AND BE IT ENACTED, That all licenses for marriages shall be issued by the clerk of the court of that county, where the woman shall have her usual residence, under the seal of his county in the form prescribed by the act concerning marriages, passed at February session 1777; and that a those parts of the several acts of Assembly of this State, which require the governor and council a supply the treasurers of the respective shores with blank marriage licences be, and the same are here by repealed?" Resolved in the affirmative.

The question was then put, shall the said bill pass? Determined in the negative.

The bill for the relief of the Morawian Society, at Graceham in Frederick county, was read the second time and passed.
