The clerk of the house of delegates delivers a bill entitled, an act to prevent the erection of booths within two miles of any Methodist camp or quarterly meeting in Frederick county, and a bill entitled, an act for the benefit of John Pointer of Worcester county, severally passed by that house Nov. 13, 1812; which were severally read the first time and ordered to lie on the table.

The president laid before the senate a letter from Robert Bowie, Esquire, late governor, relative to furnishing the government house, and covering the accounts therefor; which was read and referred to the consideration of the house of delegates.

On motion, Ordered, that the bill entitled, an act entitled, a supplement to the act of seventeen hundred and eighty five, and the supplementary acts thereto, which provide for the poor of Dorchester county, and to repeal the act of Assembly therein mentioned, be committed to a special committee. Ordered, that Mr. Frazier, Mr. Holbrook and Mr. Brown be the said committee.

5th. Strike out the word "first" in the 16th line of the third enacting clause, and insert "second" 6th. Strike out the word "first" in the 2d. line of the fourth enacting clause, and insert "second."

7th. Strike out the word "first" in the 3d line of the ninth enacting clause, and insert "second." Resolved in the affirmative.
