

The bill entitled, a supplement to an act entitled, an act to authorise the levy court of Baltimore county to assess and levy on the assessable property of said county, a sum of money to build a bridge over the Great Falls of Gun Powder River, passed at November session, eighteen hundred and eleven, and the resolutions relative to clothing the militia, were sent to the house of delegates by the clerk :

On motion, *Ordered*, that the clerk of the executive council furnish the senate with a list of the names of the persons who are justices of the levy courts and orphans courts of the several counties of this state.

The following resolution was read, assented to, and sent to the house of delegates by the clerk :

BY THE SENATE, Nov. 24, 1812.

The bill entitled, an act to incorporate a company to make a turnpike road between the streams of Big and Little Elk, through the village of Elkton, and to build a bridge over said streams in Cecil county, was read the second time, passed and sent to the house of delegates by the clerk.

The senate adjourns until to-morrow morning 9 o'clock.

WEDNESDAY, November 25, 1812.

The senate met.—Present the same members as on yesterday.—The proceedings of yesterday were read. Mr. Frazier appeared in the senate.

The bill entitled, an act to appoint commissioners to review and locate a road from the old Glass Works, called New Bremen, in Frederick county, to intersect the Baltimore and Frederick town turnpike road at New Market in the said county, was read the second time, and will not pass. Sent to the house of delegates by the clerk.

The bill entitled, a further supplement to the act entitled, an act to facilitate the draining of land in the several counties therein mentioned, was read the second time, passed and sent to the house of delegates by the clerk.

The clerk of the house of delegates delivers a bill entitled, an act for the benefit of Thomas Colsten, of Dorchester county, passed by that house, Nov. 24, 1812 ; which was read the first time and ordered to lie on the table. Also returns the resolution relative to opening letters or packets addressed to the presiding members of the legislature, endorsed, by the house of delegates, Nov. 24, 1812, read the second time by special order, and dissented from.

The president laid before the senate a letter from Ninian Pinkney, clerk of the council, covering a list of the justices of the levy courts and orphans courts of the several counties in this state ; which was read.

The bill entitled, an act to change and alter the names of Henry Cochran, of the city of Baltimore, to Henry Cochran Irvine, and of Charlotte Cochran, of the city of Baltimore, to Charlotte Cochran Irvine, was read the second time, passed and sent to the house of delegates by the clerk.

The bill entitled, an act to change the place of holding the election in the third election district in Cecil county, and for other purposes, was read the second time, passed with the proposed amendment, and sent to the house of delegates by the clerk.

*Amendment proposed.*

Strike out the word "has," in the 4th line of the 1st page, and insert "have."

The bill entitled, an act supplementary to the act entitled, an act granting a loan of money to the trustees of Charlotte Hall school, and the bill entitled, an act for the relief of John Mitchell, senr. and Richard Dove, of Prince George's county, were severally read the second time, passed and sent to the house of delegates by the clerk.

The senate adjourns until to-morrow morning 9 o'clock.

THURSDAY, November 26, 1812.

The senate met.—Present the same members as on yesterday, except Mr. MacCreery.—The proceedings of yesterday were read.

The clerk of the house of delegates delivers a bill entitled, an act authorising Ezra Mantz, late sheriff of Frederick county, to complete his collection ; a bill entitled, an act for the relief of the congregation of United Brethren, or Moravian Society at Graceham, in Frederick county ; a bill entitled, an act authorising John Creswell, late sheriff and collector of Cecil county to complete his collections, severally passed by that house, Nov. 25, 1812 ; a bill entitled, an act to discontinue the road therein mentioned, and a bill entitled, an act to regulate the fees of the register of the court of chancery, severally passed by that house Nov. 26, 1812 ; which were severally read the first time and ordered to lie on the table.

Mr. Brown appeared in the senate.
