

FRIDAY, December 4, 1812.

THE Senate met.—Present the same members as on yesterday.—The proceedings of yesterday were read. Mr. Lloyd appeared in the senate.

The resolution in favor of John Chance and John Watkins was sent to the house of delegates by the clerk.

The bill entitled, a supplement to an act entitled, an act to empower Rebecca Candler and John Candler, administrators of William Candler, late sheriff and collector of Montgomery county, to collect fees and county tax put into his hands for collection during his life time, and the bill entitled, an act for the benefit of Cornelius Ennis, John Hancock and Charity Tarr, of Worcester county, were severally read the second time by special order, passed and sent to the House of Delegates by the clerk.

The bill entitled, an act for extending Green street in the city of Baltimore, and the bill entitled, an act to alter and repeal such parts of the constitution and form of government of this state as relate to the division of Allegany county into election districts, were severally read the second time, passed and sent to the house of delegates by the clerk.

The bill entitled, an act to incorporate the trustees of the Westminster General Meeting House in Frederick county, was read the second time and will not pass.

Mr. Brown from the committee, to whom was committed the bill entitled, an act for the relief of the congregation of United Brethren or Moravian Society, at Graceham in Frederick county, reports the same without amendment.

The bill being then read, the question was put, shall this bill pass? Determined in the negative.

The bill entitled, an act to confirm an old road in Worcester county, was read the second time by special order and will pass.

The senate adjourns until to morrow morning 9 o'clock.

SATURDAY, December 5, 1812.

The senate met. Present the same members as on yesterday, except Mr. Lloyd. The proceedings of yesterday were read.

The bill entitled, an act to confirm an old road in Worcester county; the bill entitled, an act to incorporate the trustees of the Westminster General Meeting House in Frederick county, and the bill entitled, an act for the relief of the congregation of the United Brethren or Moravian Society at Graceham in Frederick county, were sent to the house of delegates by the clerk.

The bill entitled, an act to provide for opening an alley from Holliday street to North street, in the city of Baltimore; The bill entitled, an act to alter and change the name of Theodore Gunby of Somerset county, to that of Theodore Gunby Dashiell; the bill entitled, an act for the relief of Anne Onions of Prince George's county; the bill entitled, an act for the benefit of Thomas Edmondson, of Dorchester county; the bill entitled, an act to lay out and make public a road in Somerset county, and the bill entitled, an act to correct a mistake in a deed therein mentioned, were severally read the second time, passed and sent to the house of delegates by the clerk.

The clerk of the house of delegates delivers a bill entitled, an act to revive an act entitled, an act to incorporate a company to make a turnpike road from the town of Westminster, in Frederick county, through Harman's Gap, to Hager's town in Washington county, passed by that house Dec. 3rd, 1812. A bill entitled, an act to lay out, open and amend a road in Cecil county, passed by that house Dec. 4th, 1812. And the following resolutions:

BY THE HOUSE OF DELEGATES, Dec. 4, 1812.

*Resolved*, That the treasurer of the Western Shore be, and he is hereby directed and required to pay unto James Clarke or his order, a sum of money in quarterly payments, equal to the half pay of a major during the revolutionary war, as a further remuneration to the said James Clarke for the services rendered his country, and as a relief from the indigence and misery which attend his decrepitude and old age.

BY THE HOUSE OF DELEGATES, Dec. 4, 1812.

*Resolved*, That the treasurer of the Western shore be, and he is hereby directed to pay unto Leonard Watkins, a serjeant in the Maryland line during the revolutionary war, or to his order, a sum of money annually, in quarterly payments, equal to the half pay of a serjeant, as a further remuneration for those services rendered his country during the revolutionary war.

*Resolved*, That the treasurer of the Western Shore be, and he is hereby directed to pay unto Thomas Elliott, an old revolutionary soldier, or his order, annually, in quarterly payments, a sum of money equal to the half pay of a private, during the remainder of his life, as a further remuneration for his services.
